The magistrates finally fulfilled their obligation on 8th October, and two years later (1576) the lessor renounced his right in their favour. The church was leased by auction at a rent of 10, 13s. 4d. ; and, under reservation of the "kirk and the lytill hacht howss passynd furth of the queyir on the est syd wall of the said kirk callit the fowalhowss, as it is presentlie mercheit betuix four stane vallis, and of the grait foryett cloiss and passage to the kirk be the grait dur and be the lytill dur," the land was thereupon feued to David Indeaulth, Andrew King and Andrew Jack, as the highest bidders at a feu-duty of 40, "to be deput and consignit to the support of the indigent and puir in thair hospital."8 In 1587, the charter granted to the magistrates twenty years previously was reconfirmed by James VI. on attaining his majority, and on 29th July of the same year the indefinite rights of the Earl of Huntly were recognised in a Crown charter which conveyed to him, in return for a feu-duty of 40 payable to the hospital of Aberdeen and its inmates, the subjects feued by the magistrates in 1576. This conveyance in the Earl's favour was as little respected by the town as that in favour of Forbes of Monymusk, and the vassals, **Patrick and Gilbert Jack, sons of Andrew Jack**, remained in possession until 1593, when the Earl Marischal executed the deed of foundation of the magnificent college with which his name is now identified. As the friary buildings were considered most "opportune and convenient" for this purpose, the Council agreed to pay Andrew and Gilbert Jack 1800 merks in full of all their rights, and, on 24th September, after considerable dissension, "by a publict deed gave away the convent itself to the richt honourable George Erie Marishall of Scotland." The friary glebe became the garden of the Principal of the New College, and from his first rental we learn that it was worth fifty merks annually "it shold pay more bot we dispense with John Craford because he is occupied in our farmis." 8 Records of Marischal Coll. and Univ., I. 87. On 5th December, **Patrick Jack**, the successor of the last-mentioned feuar, received a Precept of Sasine from the magistrates infesting him in one-third of the Grey Friars' Place ; Charters of Aberdeen, p.391.

On the 8th October 1576, the Scottish Grey Friars was feued to David Indeaulth, Andrew King and Andrew Jack, as the highest bidders at a feu-duty of 40 pounds. The vassals, **Patrick and Gilbert Jack, sons of Andrew Jack**, remained in possession until 1593, when the Earl Marischal executed the deed of foundation of the magnificent college with which his name is now identified.

Ang. 23. masterfully closed up the bum and stopped the mill " It is foimd, be the depositions of diverse famous witnesses, that Eatreine Camegy, spouse of [a brewer], and twa of her servants; and siclyke, the spouse of David Bamsay, with **Johnie Jak** and her women servants, hes contemptuouslie casten and rowit the greit stanes of the town's wark in the Castle bum, under silence of nicht, in sic quantitie that they have stoppit the Castle mill frae grinding; whairfore they are decemit to be put in ward till they cause avoid the bum of the stanes, and till they pay to the miller ane boll of malt for the skaith bygane," and " ane half boll for every twenty-four hours they suffer the stanes to lie in the bum."

Domestic servants guilty of improper conduct were, however, treated with sufficient rigour. **Alison Jak**, having carelessly given l66l. some wandering caird -an opportunity for pillaging the kitchen, " is adjudgit to pay David Bird for his twa plates, his iron pot, and the bowls whilk sho let be stowen through her negligence and sleuth, ^hteen shillings; the whilk wes referrit to his questier,i and he-sworn ,ÄÎ deponit that the plates, pot, and bowls war better than the aid soum." Jonet BeU slandered her mistress, the housekeeper of George Falconar, and is subjected to exemplary punishment by being "ordaoit to pass to the Mercat Cross, and there upon her knees, ask her howsie [forgiveness] of her injurious words spoken to her said howsie, and never to fail to ony honest woman of this burgh, under pain of putting her in the cuck-stula"

page 309 An Enterprising merchant 1567

This is how an enterprising and adventurous merchant bound Aug. i. himself to make payment for a purchase "**Robert Jak, burgess of Dundee**, grants him have receivit frae the hands of James Findloson thir merchandises underwritten : ,ÄÎ In the first, twenty ells of velvet, with certain Lyle worst, satin of silk, sewing silk, ruben^ sOk, and other small gear extending to the soum of nine score six pounds eighteen shillings ; the whilk soum Robert hes bund and oblist him of his awn proper confession, and also actit him really and with effect, to content and pay to James at the days following,ÄÎviz, forty-six pounds eighteen shillings at the feast of Sanct John callit the Decollation of Sanct John; and the rest to be payit, the ane half thereof at the Covane day, (or Convent day, probably St Francis day, October 4th) and the other half at Andromes (Nov 30th) next to come, before witnesses " in presence of a Bailia "And failing of payment, officers to puind and prize for the samin like as this act had been made in judgment" The obligation was entered into out of court before Bailie Myln, the younger. Jak's speculations were some- times of an illegal

and perilous character ; and one of them proved to be unfortunate for him. Birrel relates in his "Diary" that, in 1567, "**Robert Jack, merchant and burgess of Dundee**, was hangit and quarterit for false coin callit hardheads, quhilk he had brought out of Flanders."

page 310 Commercial Intercourse by Land & Sea 1521-3

The scarcity of money in the early days of commercial enterprise, caused frequent resort to the primitive custom of exchanging one commodity for another. ^ Anent the condition made betwix Heniy Swan and Copyn Lyone, that is ten bolls of aitmeal for twenty-one ells of claith , Copyn is adjudgit to mak the meal as sufficient gude and as gude as the exemple that Henry provit of first, and [then Henry] to deliver the claith." A bargain having been made between John Huntar and James Kynloch" of bartering sae mony barrels of ase as draws twa tuns of wine, John deponit that he barterit the ase for wine, gif the wine likit him when he saw it The whilk wine he has seen, and likes him nocht Whairfore the judges absolve and find him free and quit of the blok of bartering." John was, however, persuaded to reconsider the matter ; for, " at the request of the Bailies, he is content to tak three puncheons of the wine, and deliver ase therefor. Therefter, being inquirit, he said, He pleasit it nocht, but he took twa tuns of wine." So it had no doubt been all right " James Fary is adjudgit, be his awn grant, to deliver to **Patrick Jak** within lawful day, three hides worth twenty shillings, and Patrik to give him a doublet of fustian again."

page 340 Craftsmen 11 Oct 1521

The Bailies admonish a lazy wright to be more diligent at his work. "Anent the complaint made be Henry Nicholson and **David Jak** upon Wat Blak, timmerman, Wat referrit to Henry's wife's and David's aith gif he wes nocht halden idle in their default, wha deponit that he wes nocht idle in their default, but in his awn. Whairfore the judges decemit Wat to perform and end his lawbour in contentment"

page 344 Offences & their punishment 1554

James Cunningam entered an action against "John ye Hay for the wrangous mispersoning of him with despiteful and evil language;" but means were taken for settling the matter out of Court "William Scrymgeour grantit that he callit **Rob Jak** smaik, () at his awn buith door ; whairfore the Bailies refer the punishment thair of to the Council" Jak, as we have seen, was a man or burghal importance, and a foreign trader on a large scale, so that making such a charge against him, although probably justifiable,, would be treated as a serious offensa He himself was not, however,, chary in using opprobrious language to others, for, not long after this,. "Thomas Stewart took acts that **Robert Jak** has injurit him in judgment, calling him gypper,() agains the fame of ane honest man ; and thairfore protestit for remeid and justica" James Denman having unwisely uttered reproaches against Olipher Lindesay, notary, "the Bailies ordain him to pass to the place whair he injurit and blasphemit Olipher, and ask him forgiveness, and also pay to the maister of the Hospital twenty shillings, to be given to the puir folks ; and gif he be again apprehendit with the like, to be banishit this burgh year and day."

Offences Against the Person

In 1545 one woman was convicted of "slandering" another by calling her "a notable thief" and other names, and the punishment adjudged upon her was that she was to "stand in irons at the will of the provost and bailies, then pass to the place where she said the evil word, and sit down on her knees and ask forgiveness, and say, Tongue you leid." If she again offended in a similar manner, she was "to be banished out of the town." "The custom which prevails among rowdy women of the present day of pulling each other's hair seems to have been prevalent in the times to which we refer, as a report is given of a woman named **Katherine Jack**, an ale-house keeper, who, besides being guilty of "slander and assault" by striking her servant, Elspeth Mukart, was also charged with "riving of her hair and casting her to the earth, and for molesting and troubling her by her evil language, calling her thief and other names." For this offence she was ordained to "pas to the merket croce this nixt Settirday (which was market-day at that period) at x houris and ane quhite wand in hir hand, and ask Elspet Mukkart forgifnes."

annals of Dundee. A very interesting account of four of them is given in a long Latin poem, written by Peter Goldman, the youngest son, and included in the *Delitlie Poetarimi Scotoram*. This curious work is entitled *Margdveta; laccJuv iriatrls 8ucg S'U2Jcr trldi et ivirnatiira niorte qwutwor filioriim Lachrymce*. (The tears of **Margaret Jack, his mother**, over the sad and immature death of her four sons.) From the poem it appears that the first-named son, Patrick, was overtaken by a sudden squall, and drowned in a harbour of Batavia (Holland). John, the second son, fell a victim to the plague in Dundee, despite the efforts made by Dr Kinloch to save him. The third son, Robert, was thrown from his horse, and instantly killed; whilst the eldest son, WILLIAM, "the beloved (if the common people, and the guardian of the welfare of Dundee," was carried off by death in the midst of his labours. *Patricium Batavis Nepiunus mersit in umJix, Pestis Iohannem rapiit, sonipexque Eohertum; Telluri, elisis, afixit, fleliile, memhrix, Et subito e.din.flf Gulielmvin funere Parca*.

page 142 - The earliest parochial transaction on record, respecting Inverurie, took place 23rd June, 1536, and was the election of a parish clerk apparently by universal suffrage, in which females as well as males voted. Similar elections, about the same time, in Daviot and Leochel are on record. It is very interesting to find, at that date, a constituency entirely popular, which has been supposed to be a gift of modern Liberalism.

The Inverurie election gives us a long list of names of the families then resident in the parish. NOTES: Clan means family group in the Gaelic. There came to be roughly three uses of the word clan: for the large clans like Clan Campbell, Clan Donald and Clan Gordon; for the smaller clans like Clan Callum or Clan Lachlan; for the sub-clans or name groups within the larger clans like Clan Tavish or Clan Arthur (the McTavishes of Dunardry and McArthurs of Tirevadich).

The idea of all members of a clan being of one name is a Victorian misconception. Clans begin to emerge as recognizable units in the 12th and 13th century. Initially the Chief and the Chief's close kin were the leaders of the clan while their followers were the local people who were their tenants or who looked to them for leadership in defense. So while the Clan Campbell were led by Campbells, until about the 18th century, many of their followers, and sometimes even they themselves often used patronymics or father's names.

Patronymics lie behind many modern Scottish family names, particularly those now beginning with the 'Mac' or 'Mc' prefix, meaning 'son of'. Further, in early records these sometimes appear with 'Vic', meaning 'grandson of'. For example Archibald MacDougall V'Gillespie (Gaelic for Archibald) was Archibald son of Dougall son of Archibald. Sometimes, such as in the 16th century, such names might even appear followed by 'alias Campbell'. In modern times families who were not of Campbell origin yet who had long given their allegiance to the Chief of the clan have come to be called "septs".

This interesting surname is of early medieval English origin, and is a surname formed from either one of two male given names, Jacob or John. Jacob derives from the Hebrew "aqob" meaning "supplanter" or "following-after". In the Bible, this is the name of the younger twin brother of Esau, who took advantage of the latter's hunger and impetuosity to part with his birthright "for a mess of pottage".

The forename James is of identical origin, and both appear as "Jacobus" in the Latin. The Old French given name "Jacques", the usual French form of "Jacobus", was introduced into England by the Normans after the Conquest of 1066, and was Anglicized variously as "Jake", "Jacke" and "Jeke". The personal name John derives from the Hebrew "Yochanan" meaning "Jehovah has favoured (me with a son)".

The popularity of this name throughout Europe is borne out by the wide variety of diminutive and pet forms it generated, including Jakke, Jak and Jack. One Petrus filius (son of) Jake was noted in the 1195 Pipe Rolls of Cornwall. The surname is first recorded in the mid 13th Century (see below) and William Jake was a witness in the Assize Court Rolls of Cambridgeshire (1260).

One of the earliest settlers in the New World was John Jack (27 yrs.), who departed from the Port of London, aboard the "Amitie", bound for St. Christopher's in the Barbados, in October 1635. A Coat of Arms granted to the family is a shield divided per saltire silver and black, with two green

leaves in pale and two gold acorns in fesse, the Crest being a green pear tree, fructed gold. The first recorded spelling of the family name is shown to be that of William Jagge, which was dated 1251, in the "Chartulary of Ramsey Abbey", during the reign of King Henry 111, known as "The Frenchman", 1216 - 1272.

Surnames became necessary when governments introduced personal taxation. In England this was known as Poll Tax. Throughout the centuries, surnames in every country have continued to "develop" often leading to astonishing variants of the original spelling.

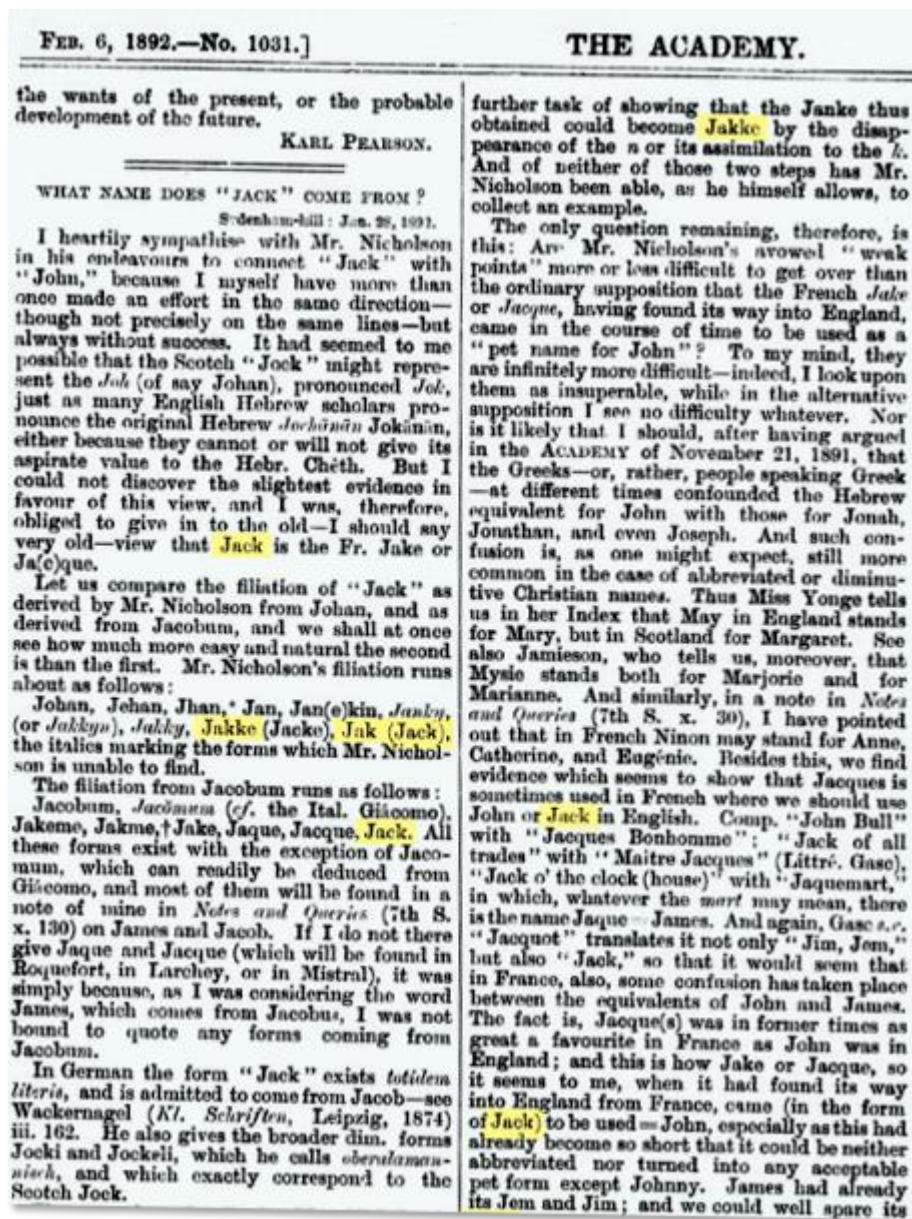


Figure 23. Clipping from The Academy Journal 6 February 1892¹⁸².

that as he was shoeing horses one day at Haddo House, the third Earl of Aberdeen (Us, as he was
familiarily called, from his excessive use of that pronoun) found fault with him for something, when,
without stopping his work, Moir said, " Please your lordship, I didn't come here to learn to shoe
horses !

"The Earl turned away in silence, but when the blacksmith had finished his task, he returned and
said, " Come up with us Moir, and I shall give you a glass of wine, for you have had a long tedious
work."

The writer was one William Jack, sometime a merchant, and after that a messenger at Elgin, who had been with the Prince, and was taken prisoner some weeks after the battle, and sent aboard one of their ships from Inverness to London. The letter was directed to several of his friends at Elgin, and came in common course of post. Though his style be none of the best, I choose to give it you in his own words :

*' Gentlemen, ,Ä This comes to acquaint you, that I was eight months and eight days at sea, of which time, I was eight weeks upon half a pound and twelve ounces oat-meal, and a bottle of water in the twenty-four hours, which was obliged to make meal and water in the bottom of an old bottle. There was one hundred and twenty-five put on board at Inverness, on the James and Mary of Fife. In the latter end of June, we was put on board of a transport of four hundred and fifty ton, called the Liberty and Property, in which we continued the rest of the eight months, upon twelve ounces of oat sheelin as it came from the mill.

There was thirty-two prisoners more put on board of the said Liberty and Property, which makes

one hundred and fifty-seven : and when we came ashore, there was only in life forty-nine, which would been no great surprise if there had not been one, conform to our usage. They would taken us from the hold in a rope, and hoisted us up to the yard-arm, and let us fall in the sea in order for ducking of us ; and tying us to the mast and whipping us if we did any thing, however innocent, that offended them : this was done to us when we was not able to stand.

I will leave it to the readers to judge, what condition they might be in themselves with the above treatment. We had neither bed nor bed-clothes, nor clothes to keep us warm in the day time. The ship's ballast was black earth and small stones, which we was obliged to dig holes to lie in to keep us warm, till the first of November last, that every man got about three yards of gross ham filled up with straw, but no bed-clothes. I will not trouble you no more till I see you.

There is none in life that went from Elgin with me, but William Innes in Fochabers ; James Brander, in Condloch, died seven months ago ; Alexander Frigge died in Cromarty Road ; John Kintrea, that lived in Longbride, died also. Mr James Falconar is well, and remains on board of a ship, called the James and Mary, lying off Tilbury Fort. I am, gentlemen, your most humble servant,

(Signed) Will. Jack."
